CONCERNING
APPOINTMENT OF PERUM PERHUTANI TO MANAGE THE FOREST AREA
FORMERLY THE CONCESSION AREA OF PT. JAMAKER IN
WEST KALIMANTAN PROVINCE AND EAST KALIMANTAN PROVINCE**

**MINISTER OF FORESTRY AND ESTATE CROPS
OF THE REPUBLIC OF INDONESIA,**

Considering :

- a. that based on the Decree of the Minister of Forestry and Estate Crops Number 347/Kpts-II/1999 dated 26 May 1999, the principle approval of the extension of the forest concession of PT. JAMAKER as put in the letter of the Minister of Forestry Number 1344/Menhut-IV/1989 dated 20 October 1989 has been canceled;
- b. that with the cancellation of the letter of the Minister of Forestry and Estate Crops pertaining to paragraph a above, the forest area formerly the concession area of PT. JAMAKER is resumed by the state, through the Ministry of Forestry and Estate Crops;
- c. that to secure, rehabilitate, utilize and recover the functions of the forest area according to its purposes, it is deemed necessary to appoint Perum Perhutani to implement the tasks through a Decree of the Minister of Forestry and Estate Crops.

HAS DECIDED :**To stipulate :****FIRST :**

To appoint and task PERUM PERHUTANI to manage the forest area formerly the forest concession of PT. JAMAKER in West Kalimantan Province and East Kalimantan Province.

SECOND :

To develop and implement programs which include all aspects of activity in accordance with the functions of the forest area pertaining to the above first stipulation.

THIRD :

To report periodically every three months to the Minister of Forestry and Estate Crops concerning all activities implemented.

FOURTH :

This decree shall take effect on the date of its stipulation.
