**THE DECREE OF PRESIDENT OF THE REPUBLIC OF INDONESIA
NUMBER 80, 1999**

ON

**GENERAL PLANNING GUIDELINES AND MANAGEMENT OF
PEATLAND DEVELOPMENT AREA IN CENTRAL KALIMANTAN**

PRESIDENT OF THE REPUBLIC OF INDONESIA

Considering :

- a. that a part of the forest area which have been set up for the peat land development area as large as 1 (one) million hectares is actually the area which by nature possessing wet land characteristic and thick peat as a part of wetland ecosystem, and functions as buffer zone which must be protected;
- b. that the other part of the PLG areas is alluvial wetland characterized by thin peat and therefore it is potentially allocated for wetland agriculture;
- c. that to achieve sustainable development of the areas, it is necessary to apply a certain approach which proper to the carrying capacity and local ecosystem characteristic by emphasizing much concern on the society empowerment and prosperity;
- d. that the peat land development scheme which based on the presidential decree, number 82 in 1995 on the development program of peat land allocated for crop product in Central Kalimantan as now has been revised for many times and the last revision is the presidential decree number 133, 1999, which is now not effective any more;
- e. that based on the consideration stated in point a, b, c, and d, it is imperative that the scheme and management of peat land development in Central Kalimantan to be rearranged and readjusted;

D E C I D E D

Stipulating : PRSIDENTIAL DECREE ON GENERAL GUIDELINES FOR PLANNING AND MANAGEMENT OF
PEATLAND DEVELOPMENT AREA IN CENTRAL KALIMANTAN.

Article 1

- (1) Development planning and management of peat land development area must be rearranged bade not only on the productivity and on the soil resources conservation and water resources sustainability principles but also be based on the appropriateness of the development and regional economic growth which is based on the land carrying capacity and biodiversity of wetland, which aimed at

enhancing people's prosperity;

- (2) Consolidation for the need of development and management of the areas beyond conservation area of the A and D work area within the peat land project area is done functionally under the coordination of the Governor of Central Kalimantan;
- (3) Shallow peat areas with less than three meter thick within the peat land development area can be used for forestry agriculture, food crops, fishery and plantation. These must be managed functionally under the coordination of the Governor of Central Kalimantan;
- (4) Wetland area with peat more than three meters thick within the peat land development project should be developed for conservation areas. For that purpose this area is managed by Department of forestry plantations;
- (5) Development planning, management, utilization and or conservation of the areas mentioned in point (2), (3) and (4) is integrated with the land use planning of the Integrated Economic Areas within Kapuas, Kahayan and Barito catchment (KAPET DAS KAKAB);

Article 2

The formulation of policies on development and management of peat land areas development must be based on the valid data or information resulted from the environmental impact analysis studies, and carried out by the interrelated institutions under the coordination of Badan Koordinasi Tata Ruang Nasional (BKTRN), the Coordinating Body for Land Use.

Article 3

- (1) Budget for every activities within the areas stated in article 1 is managed functionally by the interrelated institutions by using the available budget from Aggaran Pendapatan dan Belanja Negara (APBN), the State Income and Expenditure Budget, and Agnggaran Pendapatan dan Belanja Daerah (APBD), the Local government Income and Expenditure, and as well as from society support and private sectors.
- (2) The rest of the budget provide by the president which was stipulated in the presidential decree of the Republic of Indonesia, number 83, 1995 on the budget provision by the president, allocated for the development of peat land for food crops in Central Kalimantan, which has not been used, will be added to the APBN budget.
- (3) The rest of the budget as mentioned in point 2 above can also used functionally for supporting related sectors for the sake of consolidation under the coordination of the Badan Perencanaan Pembangunan Nasional (BAPPENAS), the National Development Planning Agency and Finance Department.

Article 4

By putting this presidential decree into effect, presidential decree number 82, 1995 on peatland development allocated for food crops in Central Kalimantan to which changes have been made twice, and the most recent one is done through the presidential decree number 133, 1998, is stipulated to be not effective anymore.

Article 5

This presidential decree is put into effect beginning from the date it is issued.
